Statement of Work Forti switch & Subscription for HJFMRI Offices

1. Overview / Purpose

This Statement of Work outlines the procurement, deployment, and ongoing support for Forti Switch devices and associated Fortinet subscriptions for FY26. These switches will be integrated into the organization's secure network infrastructure and managed via FortiGate (Forti Link) for enhanced control, visibility, and security. We will need **15 Forti switch managed switches**. Forti Switch Managed Switches required (FS-108E, FS-124F, FS-248E)

2. Scope of Work

The project scope includes:

- Supply of Forti Switch devices
- Installation, configuration, and Forti Link integration
- Activation of Forti Care and FortiGuard subscriptions (if applicable)
- Firmware updates and patching
- Monitoring and centralized management via FortiGate
- Vendor support and troubleshooting during the support term

4. Technical Requirements & Configuration

- Management Mode: Forti Link (managed by FortiGate)
- VLANs: Segmentation for LAN, VolP, CCTV, Guest Wi-Fi
- QoS Settings: Prioritize voice and video traffic
- Port Security: MAC binding, STP, Loop prevention
- Firmware Version: Must match FortiGate controller compatibility matrix

5. Implementation Timeline

6. Vendor Responsibilities

Supply switches and accessories (rack kits, SFP modules, etc.), Ensure Forti Switch devices are registered under Forti Care, Configure and test switches under Forti Link, provide post-installation documentation and diagrams, provide support during subscription term and escalate to Fortinet if needed

7. Security & Compliance

Access control to Forti Switch managed interfaces, Secure SSH/TLS for CLI or web-based management, compliance with internal network segmentation and access control policies and Fortinet security patches applied within approved change windows.
